

## **OVERVIEW**

#### What is the MCB?

The Moot Court Bench is Sri Lanka's first fully integrated legal advocacy training platform. The main aim of the MCB is **enhancing the standard of the legal profession**, by delivering education of global standards for Sri Lankan law students focusing on **International Commercial Arbitration**, **International Trade Law**, **International Commercial Mediation and Negotiation**.

#### What is Arbitration?

Arbitration is a highly practiced form of Alternate Dispute Resolution (ADR) globally. It facilitates a **speedy, efficient, and binding method of resolving disputes** away from the backlog and bureaucracy of courtrooms.

In arbitration, each party is represented by their counsel before an Arbitral Tribunal, either appointed by the parties or an Arbitral Institution. Despite lacking the authority of a judgment from court, the Tribunal issues a binding Award at the conclusion of proceedings, serving as the final decision.

#### Is it for you?

Learning skills of arbitration will present you with new avenues in your career, as arbitration is widely accepted within Sri Lanka, and to an even greater extent globally.

### THE ICA PROGRAM

The International Commercial Arbitration (ICA) Program of the MCB was established in 2020, driven by the understanding of arbitration's global momentum and the lacuna of resources for students eager to master this discipline.

This initiative aims to elevate the standards of arbitration in Sri Lanka by addressing the scarcity of available resources for law students. Expanding its horizon, the program now offers students worldwide the chance to delve into the fundamentals of arbitration and refine their skills in written and oral advocacy.

#### How does it work?

The ICA Program focuses on three main subject areas:



The basics of International Commercial Arbitration

The United Nations Convention on the International Sale of Goods (CISG)



Written advocacy in the form of legal memoranda and oral advocacy in the form of legal submissions.

The Course is taught by legal academics and professionals along with MCB Alumni with sound knowledge in the respective areas.

The ICA Program classes would take place during weekends for the duration of the three months. In addition to learning the theoretical aspect of arbitration, the participants will be taught and given an opportunity to test their practical knowledge through the deep dive into the 31st Vis Moot Problem and the mooting sessions.

This year, the ICA Program would extend for a period of 3 months, from the beginning of June 2024 to the end of August 2024.



#### **MCB ICA National Competition**

After the course of three months, the Top four contenders from each University will be selected to represent their University in the National Competition.

Thereafter, the Top two Teams will be selected to participate as the teams from Sri Lanka in the Prestigious Willem C. Vis International Commercial Arbitration Moot which is held annually in Vienna, Austria or its sister moot, the Willem C. Vis East International Commercial Arbitration Moot which is held annually in Hong Kong.
